I. Call to Order:

President Beverly Powell called the meeting to order at 5:10 p.m.

II. Welcome & Introductions:

III. Approval of minutes from June 12, 2019

IV. SBVC President's Report

President Rodriguez reported.

- Our enrollment numbers for this semester are incredible. The college is more than
 a couple FTES over the target that we need to be. Kudos was given to the faculty
 and classified professionals who have welcomed the students and helped to get
 the message out to the community. The numbers did not just increase because
 of the Promise Program, but there was an increase in other age groups. Our goal
 is to retain those students. The college is going to strategize on how they will
 address the FTES for the summer.
- Based on the new funding formula, the district has earned 2 million dollars more than what the State is going to give. The State is taking the funds from districts that did very well and using it to help other districts be whole. So far, region nine has taken the biggest hit on this.

- Currently, the college is working on their accreditation. Dr. Huston has done a remarkable job crafting the document. The first draft is just about completed. The accreditation will be in 18 months.
- This Friday evening is the Black Rose event at the National Orange Show. There are two tickets available. This is a scholarship event and members of the community will be recognized.

 them to grow.
 - Hall of Fame is schedule for November 8th, at the DoubleTree Hotel in San Bernardino. Currently, there are six nominations for Hall of Fame.
 - Alumni & Friends Rally is scheduled for November 9th, outside of the SBVC Football Stadium from 4:00pm – 5:30pm.
- 2020 Golf Tournament
 - There are two venues that are of interest: Arrowhead Country Club and Shannon Hills Golf Course. Arrowhead has made a few changes since the last tournament and are excited to have SBVC back for another tournament. The decision of where the tournament will be hosted will depend on the price.
